The affiliation proposals, accredited by Quality Council of India (QCI), forwarded to DGT, Ministry of Skill Development and Entrepreneurship were put up before the members of the Sub-Committee of National Council for Vocational Training (NCVT) dealing with affiliation of ITIs in its meeting dated 25.08.2015 for its consideration and approval.

The Committee considered affiliation proposals and accorded approval to proposals conforming to the NCVT Norms. Part-I of Affiliation orders, State wise, were issued & Part II of these affiliation orders was to be issued upto 31st August 2015.

In continuation to above, Affiliation Orders-Part II, have been issued & enclosed for information. These cases cover clarifications cases of previous meetings i.e. 23rd June, 30th July & 25th August, 2015, any other cases included in the Agenda of the meeting dated 25th August, 2015, & those received from QCI after accreditation. The orders are also uploaded on the website dget.gov.in.

In this regard the following points may be noted:

- > This supersedes any other earlier clarification order issued in previous meeting with reference to current session i.e. August 2015.
- > All those cases cleared up to the NCVT Sub-Committee meeting dated 30th July, 2015 would not get any extension in admissions beyond 31st August, 2015.
- > The affiliation orders issued vide letter dated 25th August 2015 and later, for the session August 2015 would get extension for admitting trainees upto 17th September 2015.


